# Participant Biographies

## **Sergio Abreu**

Sergio Abreu is president of the Uruguayan Council for International Relations. He was previously a senator; minister of industry, energy, and mining; minister of foreign affairs, in which position he chaired the Uruguay Round; and administrative and finance director of the Latin American Integration Association. Abreu is a member of the Inter-American Bar Association, the Argentine Council for International Relations, and the National Academy of Economics. He is a professor in the master of international relations program at the University of Montevideo and the University of the Republic of Uruguay (UDELAR), and the author of several publications. Abreu has a master's degree in public administration from the University of Southern California and a doctorate in law and social sciences from UDELAR. He also studied at the Southwestern Legal Foundation, University of Texas at Dallas, the Center for International and Comparative Law, and The Hague Academy of International Law.

## **Riccardo Alcaro**

Riccardo Alcaro is coordinator of research and head of the Global Actors program at the Institute of International Affairs (IAI) in Rome. He is also a fellow of the European Foreign and Security Policy Studies program. Alcaro previously coordinated Transworld, a multi-year EU-funded project on transatlantic relations and global governance. He was a visiting fellow at the Center for the United States and Europe at the Brookings Institution and has contributed to the Economist Intelligence Unit's quarterly publication on the EU, the *European Policy Analyst*. Alcaro holds a PhD from the University of Tuebingen.

## **Jessica De Alba Ulloa**

Jessica De Alba Ulloa is a member of the Mexican Council on Foreign Relations. She is also a research professor at the Universidad Anahuac Mexico's School of Global Studies, member of the National System of Researchers, O'Gorman fellow at Columbia University Institute of Latin American Studies, and a 2017 scholar in the Study of the U.S. Institutes on U.S. National Security Policymaking program. She was previously an advisor to the Mexican undersecretary of foreign affairs, advisor to the commissioner of the National Immigration Institute, and delegate of the Mexican mission to UN Educational, Scientific, and Cultural Organization. She has taught at French and Mexican universities and is member of a Paris-Saclay research center. She has edited a book on international relations theory and on Mexican foreign policy, and authored nine book chapters and several journal articles. De Alba Ulloa is also a frequent media commentator on foreign affairs in Mexico and the United States. She holds a bachelor's degree in international relations from Universidad de las Americas and a master's degree in diplomacy and negotiation and a doctorate in political sciences from the University of Paris-Sud.

## **Sławomir Dębski**

Sławomir Dębski is director of the Polish Institute of International Affairs, a position he previously held from 2007 to 2010. From 2011 to 2016, he was director of the Centre for Polish-Russian Dialogue and Understanding, and the editor in chief and editorial board member of the online journal *Intersection: Russia/Europe/World*. He has been a member of the Polish-Russian Group for Difficult Matters since 2008. He was editor in chief of the Russian-language quarterly *Evropa* as well as the bimonthly *Polish Diplomatic Review*. He is the author of *Between Berlin and Moscow: German-Soviet Relations, 1939–1941*, which won the Klio Award and an award from *Eastern Review*, as well as articles and collections of sources on diplomatic history. Dębski received a PhD in history from Jagiellonian University in 2002.

## **Mark Fitzpatrick**

Mark Fitzpatrick is executive director of the International Institute for Strategic Studies (IISS) Americas office and head of the IISS Non-Proliferation and Nuclear Policy program. He joined IISS after a twenty-six-year career in the U.S. Department of State, including as acting deputy assistant secretary for nonproliferation. He is the author of *Asia's Latent Nuclear Powers: Japan, South Korea and Taiwan; Overcoming Pakistan's Nuclear Dangers*; and *The Iranian Nuclear Crisis: Avoiding Worst-Case Outcomes*; and the editor of six books on countries and regions of proliferation concern. He has lectured throughout the world and is a frequent media commentator. He is a cofounder of the EU Non-Proliferation Consortium.

## **Jacek Foks**

Jacek Foks is deputy director of the Polish Institute of International Affairs, a position he previously held from 2003 to 2010. He was formerly director of the department of planning and sport policy, and undersecretary of state for the Polish ministry of sport and tourism. He has been special secretary of the International Associations of Sports Law since 2008. He is a former member of the Polish UNESCO Committee and the foundation board of the World Anti-Doping Agency. He was previously editor in chief of the *Polish Foreign Affairs Digest* and a member of the board of editors for the *Polish Diplomatic Review* and *Polish Quarterly of International Affairs*. He is author or coauthor of dozens of articles, and his main research interests include EU law, international sports law, and sports and international relations. He has an LLM from the University of Warsaw.

## **Michael Fullilove**

Michael Fullilove is the executive director of the Lowy Institute, with which he has been associated since its establishment in 2003. He wrote the feasibility study for the Lowy Institute in 2002 and served as the director of its global issues program from 2003 to 2012. He has also been a visiting fellow in foreign policy at the Brookings Institution, an advisor to Prime Minister Paul Keating of Australia, and a lawyer. He remains a nonresident senior fellow at the Brookings Institution. Fullilove writes widely on Australian and U.S. foreign policy and global issues in publications including the *Financial Times*, *Foreign Affairs*, *Foreign Policy*, *National Interest*, *New York Times*, *Washington Post*, and the Australian press. As a speaker and commentator, he has appeared on *Radio National Breakfast*, ABC's 7.30, and the *Charlie Rose Show*. Fullilove graduated in arts and law from the Universities of Sydney and New South Wales, with dual university medals. He studied as a Rhodes scholar at Oxford University, where he received an MA and PhD in international relations.

## **Thomas Gomart**

Thomas Gomart is director of the French Institute of International Relations (IFRI), based in Paris and Brussels. He was previously its vice president for strategic development and the director of its Russia/NIS Center. He is also the coeditor of the trilingual electronic series *Russie.Nei.Visions*. Gomart's current research focuses on Russia, digital governance, country risk, and think tanks. Before joining IFRI, Gomart was an assistant professor at the Sorbonne, cadet officer in the army, Lavoisier fellow at the Moscow State Institute of International Relations, visiting fellow at the European Union Institute for Security Studies in Paris, and Marie Curie fellow at the department of war studies in King's College London. Gomart has also managed many projects with leading international think tanks. He recently published "The Return of Geopolitical Risk: Russia, China, and the United States" in *Etudes de l'Ifri* and "La France face aux trois grands (Etats-Unis, Chine et Russie)" in *Revue des deux mondes*. He recently coedited *Notre intérêt national: Quelle*

*politique étrangère pour la France?* for Odile Jacob, with Thierry de Montbrial, and “Foreign Policy Challenges for the Next French President” in *Etudes de l’Ifri*, with Marc Hecker. Gomart holds an EMBA from Hautes Etudes Commerciales de Paris and a PhD in history from the Pantheon-Sorbonne University.

### **Richard Haass**

Richard Haass is in his fifteenth year as the president of the Council on Foreign Relations, the preeminent independent, nonpartisan organization in the United States devoted to issues of foreign policy and international relations. He was the senior Middle East advisor to President George H.W. Bush and director of the State Department’s policy planning staff, where he was a principal advisor to Colin Powell. He has also served as U.S. coordinator for policy toward the future of Afghanistan and as the U.S. envoy to both the Cyprus and Northern Ireland peace talks. A recipient of the State Department’s Distinguished Honor Award, the Presidential Citizens Medal, and the Tipperary International Peace Award, Haass is also the author or editor of thirteen books on U.S. foreign policy and one book on management. His latest book is *A World in Disarray: American Foreign Policy and the Crisis of the Old Order*. A Rhodes scholar, he holds a master’s degree and a doctorate from Oxford University.

### **Ross Harvey**

Ross Harvey has worked for the South African Institute of International Affairs (SAIIA) since 2013. His work initially focused on labor relations in the mining sector in South Africa and has since expanded to extractive industry governance. He has led SAIIA’s work on the illegal wildlife trade, especially in elephant ivory and rhino horn. His academic research focuses on explaining institutional divergence in post-independence Nigeria and Angola, both states that are equally dependent on oil revenue. Harvey has also written on the fourth industrial revolution and the importance of adopting new technology both to diversify economies and address the constraints to development in developing countries. Harvey has an MPhil in public policy from the University of Cape Town, where he is currently pursuing a PhD in economics.

### **Sunjoy Joshi**

Sunjoy Joshi is chairman of the Observer Research Foundation (ORF). After serving in government for over twenty-five years, Joshi took voluntary retirement from the Indian Administrative Service, and has since 2009, overseen the transformation of ORF into India’s foremost think tank in a range of sectors, from foreign policy and internet governance to development studies and national security. Joshi writes regularly on strategic issues relating to India’s energy needs and their interplay with the country’s development challenges in the context of the contemporary climate change narrative. His long-form publications include “The Future of Energy,” an ORF and Economic Policy Forum collaboration; “Reforming Energy Policy and Pricing,” as part of *Getting India Back on Track: An Action Agenda for Reform*; “The Search for Energy Security,” as part of *Crux of Asia: China, India, and the Emerging Global Order*; and “Beyond the Plateau in U.S.-India Relations,” a Heritage Foundation report. Joshi has been a visiting associate at the International Institute of Strategic Studies as well as distinguished visitor to the program on energy and sustainable development at Stanford University.

### **Memduh Karakullukçu**

Memduh Karakullukçu is the vice chairman and president of Global Relations Forum (GRF). His policy work at GRF includes global energy dynamics, European energy security, global economic and financial governance, and the economic prospects of the Middle East and North Africa region. He is currently co-chairing GRF’s international task force on the future of the Iran nuclear deal. Karakullukçu is also the

founding partner of the Turkish online legal informatics initiative, Kanunum.com. Previously, he served as the founding managing director of Istanbul Technical University (ITU) ARI Teknokent, an innovation community of over one hundred technology companies. During his tenure at ITU, Karakullukçu was the senior advisor to the president; the coordinator of the law, technology, and policy graduate program; and the strategic advisor at the university's center for satellite communications. Karakullukçu has also served as a member of the academic staff at ITU and the London School of Economics and Political Science (LSE). Earlier in his career, he worked as a specialist in structured finance in London and Istanbul. Karakullukçu received a BS in electrical engineering and economics from the Massachusetts Institute of Technology, an MSc in finance from LSE, and a JD from Columbia University.

### **Hans-Peter Keitel**

Hans-Peter Keitel is an honorary professor at Berlin Technical University and member of the Academy for Technical Sciences. Keitel served as president of the Council of the German Institute for International and Security Affairs (SWP) from 2007 to 2017. Previously, he worked at Lahmeyer International, Consulting Engineers, Frankfurt/Main, and Hochtief, where he was member of the executive board from 1990 to 1992, and chairman of the executive board from 1992 to 2007. From 1992 to 1999, Keitel was also a member of the executive board at Hochtief's parent company RWE Group. He is on the boards or supervisory boards of numerous companies such as Voith, KGaA, Airbus, ThyssenKrupp, and National-Bank, among others. From 2009 to 2012, he was president of the Federation of German Industries; thereafter, he served as its vice president until 2016. Keitel earned his degrees in civil engineering as well as industrial sciences and economics, and received his doctorate from the Technical University of Munich.

### **Sergey Kulik**

Sergey Kulik serves as the director for international studies at the Institute of Contemporary Development. He is also a member of the academic council of the Security Council of the Russian Federation and the Council for Foreign and Defense Policy. He previously served as the director of the department for relations with the European Union, deputy director of the foreign policy and the information policy departments of the Russian presidential administration, director of the Arms Control Center at the Russian Academy of Sciences' Institute for the U.S. and Canadian Studies, and project leader at the Stockholm International Peace Research Institute.

### **Marlos Lima**

Marlos Lima is executive director of the Latin American Center for Public Policy at the Getulio Vargas Foundation (FGV) in Brazil. Lima has been involved in many projects in private and public initiatives abroad and in Brazil. He is also visiting professor at many universities in Latin America as well as founding member of the Latin American Group for Public Administration and the American Academy of Management. He is an economist at the Brazilian School of Economics, holds a master's degree in public administration from FGV, and a PhD from the University of Rennes, France.

### **Joseph Chinyong Liow**

Joseph Chinyong Liow is dean and professor of comparative and international politics at the S. Rajaratnam School of International Studies. He previously held the inaugural Lee Kuan Yew Chair in South-

east Asia studies at the Brookings Institution, where he was also a senior fellow in the Foreign Policy program. Liow's research interests encompass Muslim politics and social movements in Southeast Asia and the international politics of the Asia-Pacific region. Liow is the author, coauthor, or editor of fourteen books, including *Ambivalent Engagement: The United States and Regional Security in Southeast Asia after the Cold War*, *Religion and Nationalism in Southeast Asia*, and *Dictionary of the Modern Politics of Southeast Asia*. Liow has also consulted for a wide range of multinational corporations and sits on the board of several peer-reviewed academic and policy journals and the expert panel of the Social Science Research Council. Liow is also Singapore's representative on the advisory board of the ASEAN Institute of Peace and Reconciliation. Liow holds a BA in political science from the University of Wisconsin-Madison, an MSc in strategic studies from the Nanyang Technological University, and a PhD in international relations from the London School of Economics.

### **José María Lladós**

José María Lladós is the executive director of the Argentine Council for International Relations. Previously, he served as the Argentinian secretary of defense production and secretary of planning during the presidencies of Raul Ricardo Alfonsín and Fernando de la Rúa, respectively. He has also been advisor to the defense committee of the National Chamber of Deputies. ### **Fyodor Lukyanov**

He is editor in chief of *Russia in Global Affairs*, a journal published in Russian and English with the participation of *Foreign Affairs* since 2002. Lukyanov is also research director of the Valdai Discussion Club and member of the presidium of the Russian International Affairs Council. He is also a research professor at the National Research University Higher School of Economics.

### **Bessma Momani**

Bessma Momani is a senior fellow at the Centre for International Governance and Innovation (CIGI) and nonresident senior fellow at the Brookings Doha Center. She is also professor of political science at the University of Waterloo and the Balsillie School of International Affairs. Momani has authored and coedited several books and over seventy scholarly, peer-reviewed journal articles and book chapters that have examined the International Monetary Fund, World Bank, petrodollars, Middle East, and Arab youth. ## **Haibin Niu**

O'Neil previously worked in the private sector as an equity analyst at Indosuez Capital and Credit Lyonnais Securities. She holds a BA from Yale University, an MA in international relations from Yale University, and a PhD in government from Harvard University.

## **Stewart M. Patrick**

Stewart M. Patrick is the James H. Binger senior fellow in global governance and the director of the International Institutions and Global Governance program at the Council on Foreign Relations. From 2005 to 2008, he was a research fellow at the Center for Global Development, where he directed research and policymaking at the intersection of security and development. Patrick has also served on the U.S. State Department's policy planning staff, with lead staff responsibility for U.S. policy toward Afghanistan and a range of global and transnational issues. Prior to government service, Patrick was a research associate at the Center on International Cooperation at New York University. He has taught at Johns Hopkins University's School of Advanced International Studies and at New York University. ## **Félix Peña**

Félix Peña is vice chairman of the Argentine Council for International Relations. He is also director of the Institute of International Trade at the ICBC Foundation and of the master's program in international trade relations at the National University of Tres de Febrero. Peña is a specialist in international economic relations

and negotiations, economic integration, and foreign trade policy. He was previously undersecretary of foreign trade in the Argentine ministry of economy in charge of Mercosur affairs; undersecretary of economic integration in Argentina's foreign ministry, also in charge of Mercosur affairs, and undersecretary for international economic relations; deputy manager for integration at the Inter-American Development Bank (IADB); and director of the Institute for the Integration of Latin America and the Caribbean, a unit of the integration and trade sector of IADB. ### **Adalberto Rodríguez Giavarini**

Adalberto Rodríguez Giavarini is president of the Argentine Council for International Relations, is a member of the advisory council and grand jury at Konex Foundation, and runs the foreign affairs chapter of the Political Action Network Foundation. Rodríguez Giavarini also chairs the executive board of his consulting group specializing in national, regional, and international political economy, is vice president of the National Academy of Education in Argentina, and is a member of the board of directors at the National Academy of Moral and Political Sciences. He was previously the Argentine minister of foreign affairs and international trade and a member of the Congress. He also served, at the beginning of the current democratic period, as undersecretary of the treasury and secretary of defense. Rodríguez Giavarini has participated as a main speaker in several seminars and conferences in Argentina and abroad. He has published numerous essays and articles in national and international newspapers and magazines. He is a professor honoris causa at Soka University, Japan, and has been decorated by sixteen countries. Rodríguez Giavarini received his degree in economics from the University of Buenos Aires, where he later returned as professor of macroeconomics.

### **Samir Saran**

Samir Saran is vice president of the Observer Research Foundation (ORF) and heads the foundation's outreach and business development activities. He curates the Raisina Dialogue, an annual conference on geopolitics and geoeconomics, and chairs CyFy, an annual conference on cybersecurity and internet governance. Saran is a commissioner on the Global Commission on the Stability of Cyberspace and a member of the South Asia advisory board and Global Future Council on Cybersecurity of the World Economic Forum. He is director of the Sardar Patel Police University's Center for Peace and Security. His academic publications include *India's Climate Change Identity: Between Reality and Perception*, coauthored with Aled Jones; "New Norms for a Digital Society," an ORF special report; "India's Contemporary Plurilateralism"

in the *Oxford University Press Handbook on India's Foreign Policy*; and “Navigating the Digital Trilemma” in the latest *CyFy Digital Debates*, of which he is the editor; among others. Saran is a frequent commentator in Indian and international print media on global governance, including climate change and energy policy, global development architecture, cybersecurity and internet governance, and India's foreign policy. Saran received his electrical and electronics engineering degree from the Manipal Institute of Technology and his master's degree in media studies from the London School of Economics and Political Science. His doctoral studies at the Global Sustainability Institute were on Indian attitudes toward climate change.

### **Gilead Sher**

Gilead Sher heads the Center for Applied Negotiations at the Tel Aviv University's Institute for National Security Studies. He is a former Israeli chief and co-chief peace negotiator at the Camp David summit and the Taba talks, and served as former Prime Minister Ehud Barak's chief of staff and policy coordinator. Formerly, under Prime Minister Yitzhak Rabin, Sher was a delegate to the 1994–1995 Interim Agreement negotiations with the Palestinians. He co-chairs the nonpartisan organization Blue White Future and chairs Sapir Academic College, Israel's largest public college. In 2016, Sher served as a lecturer on law at Harvard Law School. He previously lectured for ten years as a guest scholar at the University of Pennsylvania's Wharton School and authored *The Israeli-Palestinian Peace Negotiations, 1999–2001: Within Reach* and coedited *Negotiating in Times of Conflict* and *Spoilers and Coping with Spoilers in Israeli Peacemaking*. His book *The Battle for Home* was published in 2016. He was nominated by Expert Guides as one of the leading Israeli arbitrators.

### **Oliver Stuenkel**

Oliver Stuenkel is an associate professor of international relations at the Getulio Vargas Foundation, where he coordinates the São Paulo branch of the School of History and Social Science and the executive program in international relations. He is also a nonresident fellow at the Global Public Policy Institute in Berlin, a member of the Carnegie Rising Democracies Network, and a columnist for *El Pais* and *Americas Quarterly*. His research focuses on the foreign policy of Brazil, India, and China, and their impact on global governance. He is the author of *IBSA: The rise of the Global South?, BRICS and the Future of Global Order*, and *Post-Western World*.

### **Hayanari Uchino**
